## COMMON ORDER BELOW BAIL APPLICATION NOS. 1653/2022, 1654/2022, 1655/2022 AND (Exh. 5)

- 1. Read the applications and say of Ld. A.P.P. in Bail application Nos. 1653/2022, 1655/2022 and (Exh. 5). Bail application No. 1654/2022 is taken for consideration without say of Ld. A.P.P.
- **2.** All applications are taken together for decision. Perused record. On 11/11/2022 investigating officer filed final report under Section 173 the Cr. P. C.
- **3.** Heard both sides at sufficient length. Also gone through judgments cited by Ld advocates for the applicant accused.
- 4. Prosecution case is that initially informant applied for loan through Kuberan App. Accordingly, some amount was deposited in her account. But it was less than what she had applied for therefore, she refused to borrow the loan. Thereafter, she was compelled to download various applications in her mobile. Thereafter, some amount was deposited in her account and then these accused started threatening her for repayment of that loan amount. Even they have morphed her photographs and started sharing it to the relatives of informant from her contact list. Informant is deceived and cheated by the accused. After due investigation, investigating officer filed charge-sheet before this Court.
- **5.** On perusal of record, it would reveal that applicant/accused were arrested in this crime on 16/09/2022. Initially they were arrested in

another crime and they were transferred and produced before this Court after getting production warrant therefor. No doubt offences are serious in nature. But, as mentioned earlier investigation is complete and final report is before the Court. It will take considerable period for trial of case on merits. In such situation no purpose will be served by keeping the accused in MCR for indefinite period. So far as apprehension expressed by the prosecution is concerned that can be taken care of by

## **ORDER**

- 1) Accused Adnan Salim Ahmed, Vipul Shankerppa Gauda, Owaiz Saleem Ahmed and Liang Chi Sheng are released on bail in the sum of Rs. 30,000/- (Rs. Thirty thousand) each with one or more sureties in the like amount.
- 2) They shall not commit the offence similar to this offence.
- 3) They shall not tamper the prosecution evidence.

imposing certain conditions. Hence, order;

- 4) They shall furnish their permanent ID proof alongwith residence and work place addresses of three close blood relatives.
- 5) They shall attend the Court on each date unless exempted.
- 6) Provisional cash security is allowed till 28/12/2022.
